## AN ORDINANCE AUTHORIZING SUPPLEMENTAL APPROPRIATIONS - Public Safety Fund for Salaries and Benefits

WHEREAS, the Finance Department completed a review of all accounts as of the end of the third quarter to determine if any accounts appeared to have an insufficient budget balance to complete the year; and

WHEREAS, the Public Safety Fund was identified as needing additional funding in the amount of \$175,000 for salaries and benefits; and

WHEREAS, the need for the additional funds is due to assigning a school resource officer (SRO) position for a full year beginning January 1, 2024 that was originally budgeted for only a partial year; and

**WHEREAS**, a transfer of appropriations in the amount of \$100,000 via RES-0041-2024 covers part of the request, a supplemental appropriations in the amount of \$75,000 is requested to cover the remaining amount needed.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

**Section 1.** That funding in the amount of seventy-five thousand dollars (\$75,000) is hereby supplementally appropriated from the unappropriated, unencumbered balance of the Public Safety Fund (2400) as follows:

240.10.110.5115 - Public Safety Overtime: \$15,000 240.10.110.5135 - Public Safety Insurance: \$55,000 240.10.110.5140 - Public Safety Workers Comp: \$3,000 240.110.110.5145 - Public Safety Medicare: \$1,500 240.110.5150 - Public Safety Uniform Allowance: \$300 240.10.110.5160 - Public Safety Other Benefits: \$200

**Section 2.** That this Ordinance shall be in full force and effect after passage by Council and on date of signature of approval by the Mayor.
