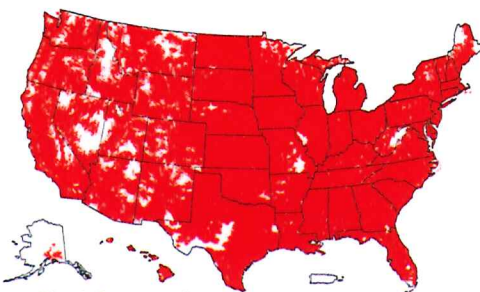

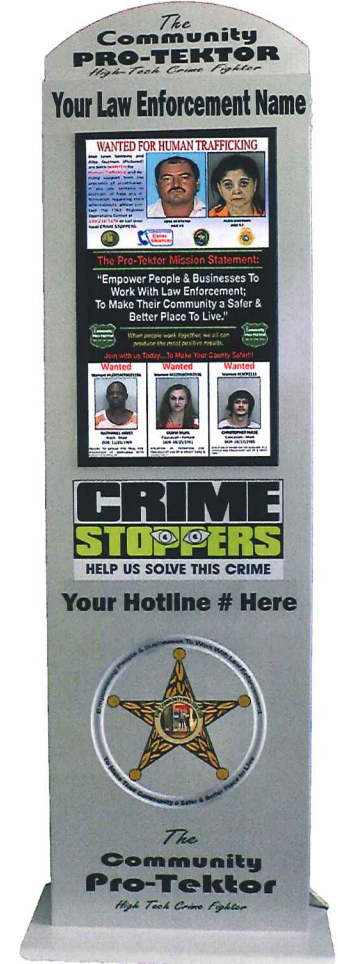
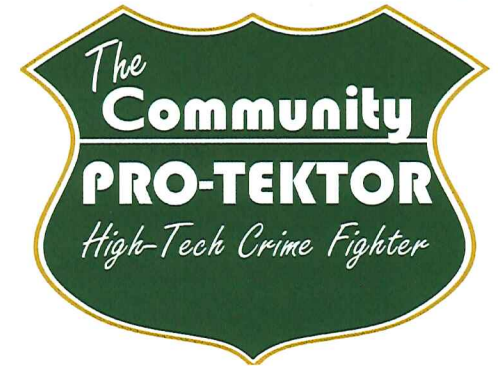

MARION COUNTY EARNS NATIONAL ACHIEVEMENT AWARD FOR CRIME INFORMATION/PREVENTION KIOSK PROGRAM

MARION COUNTY, FLORIDA (June 16, 2015) – Marion County's Crime Information/Prevention Kiosk Program has been recognized with an Achievement Award from the National Association of Counties (NACo). The awards honor innovative, effective government programs that enhance services for residents. NACo recognized the Crime Information/Prevention Kiosk program in the category of criminal justice and public safety.

The Marion County Sheriff's Office kiosk program is an informational crime prevention system that displays wanted persons, missing and endangered persons, public service announcements and other messages that can be distributed to the public. Since the inception of the kiosk program in July 2014 by Marion County Sheriff Chris Blair, over 192 wanted subjects have been placed on the kiosk and 94 individuals have been captured after being featured. Over 100 kiosks are currently in place in businesses and public places in Marion County and business owners find that the kiosk not only acts as an informational outlet for their customers but the kiosk deters crime in their establishments. Sheriff Blair's goal is to expand this program and encourage other sheriffs in the state, region and nation to utilize this successful crime prevention tool.

"It is my hope that law enforcement agencies around the state and nation will see how important this kiosk can be to their organizations and communities alike," said Sheriff Blair. "If other agencies adopt this program, we could share critical information across multiple jurisdictions. Those with access to the kiosk system can update and post information within minutes from any mobile device, reaching every kiosk in the network instantly. Having a tool like this could change the game when it comes to time-sensitive investigations such as a missing person or child, an Amber Alert or a Silver Alert."

Over the past several months, several other Florida sheriffs' offices have adopted the kiosk program in their counties. This kiosk is a part of a coordinated effort between Sheriff Blair and the Marion County Board of County Commissioners to provide the best public safety services to the citizens of Marion County.

"The Marion County Board of County Commissioners is proud to have partnered with the Marion County Sheriff's Office on this effort. This is an innovative crime prevention tool that has been very effective for the citizens of Marion County," said Marion County Commission Chairman Stan McClain.

The Marion County Sheriff's Office has seen a crime decrease of 8.9% in two years and Sheriff Blair believes that his crime prevention programs, like the kiosk, have played a significant role in this accomplishment.

"We cannot measure crime prevention, but I do believe that this program will contribute to reducing crime in our community through identification and apprehension," said Sheriff Blair.

NACo President Riki Hokama, council member, Maui County, Hawaii, said, "The National Association of Counties applauds county governments that are embracing innovative and more effective ways to serve their constituents. The Achievement Awards recognize counties' outstanding efforts to strengthen services and deliver results for residents across the country."

Nationally, awards are given in 21 different categories that reflect the vast, comprehensive services counties provide. The categories include children and youth, criminal justice, county administration, environmental protection, information technology, health, civic engagement and many more.

The awards will be presented at NACo's 2015 Annual Conference and Exposition July 10-13 in Mecklenburg County, N.C.

Started in 1970, NACo's annual Achievement Award Program is designed to recognize innovative county government programs. Each nominee is judged on its own merits and not against other applications received. The National Association of Counties (NACo) unites America's 3,069 county governments.

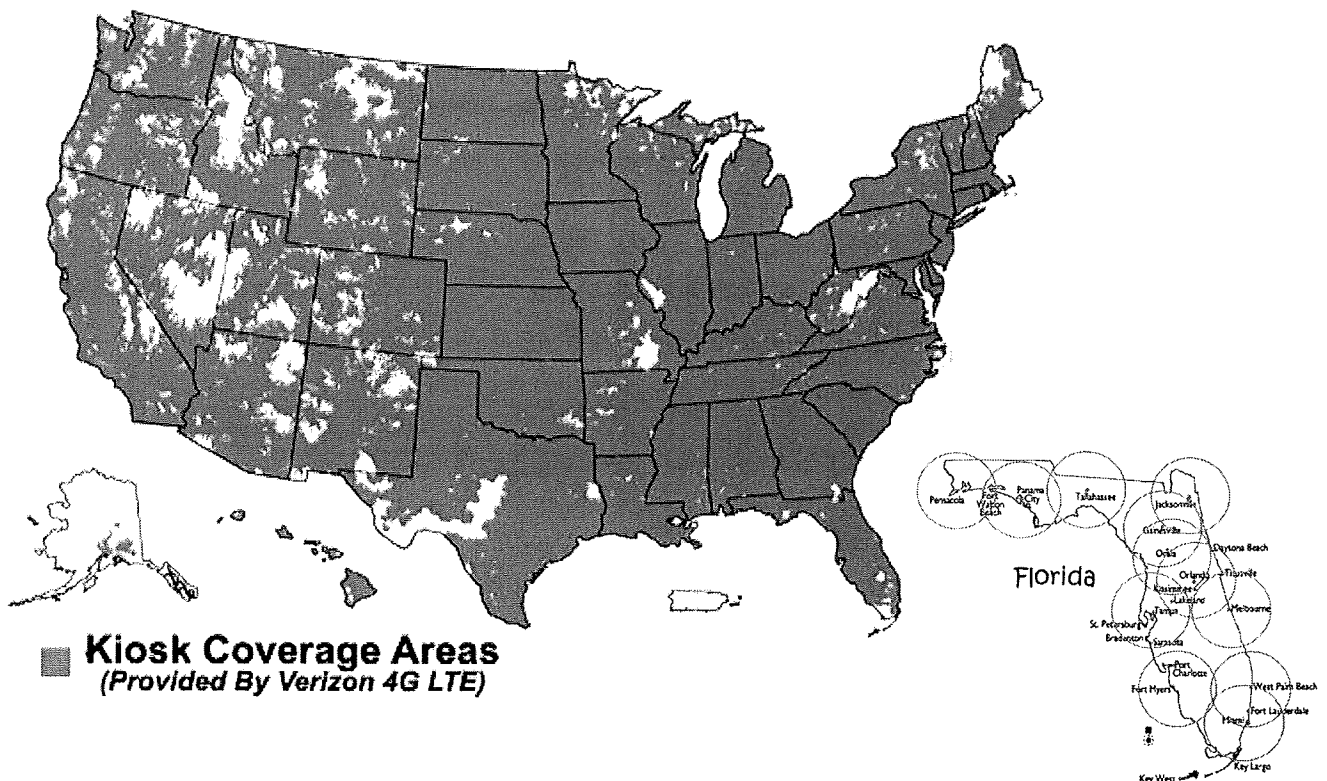

This new kiosk system is designed to be law enforcements own personal news network for issuing real-time community alerts, notifications and warnings to the general public for assistance in locating missing people, help identifying people of interest, and issuing positive community PSA's messages from the Sheriff or Chief.

On a local County by County basis the Community Pro-Tektor Kiosk will give agencies the ability to work together in solving local crimes by placing their own Alerts in high traffic areas of their communities. Using the general public as a team of "watchful eyes" will help reduce law enforcement investigative costs and assist in solving community issues & crimes quicker.

The Community Pro-Tektor's radial usage feature is the preferred method of connecting together counties across the entire State of Florida to allow law enforcement the use of The Community Pro-Tektor Kiosk system in all surrounding counties. From the point of origin of any criminal activity an instant alert, notification or warning can be issued to create public awareness to the situation and in return produce leads that will result in quicker apprehension. This will happen faster than the criminal can flee the area in any direction.



On a National basis, nearly a million people are reported missing per year across the country, law enforcement agencies spend millions & millions of dollars and thousands of law enforcement officer's time investigating & searching for missing people. The Community Pro-Tektor Kiosk system has produced proven results in a very short period of time by Florida law enforcement agency for getting detailed messages to the public and receiving tips that have lead to the following solved cases.

The cases below can be verified by media coverage listed on the company website and/or the Marion County Sheriff's office. Names of individuals have been withheld to protect the guilty and to not give the criminal any glory.

The Community Pro-Tektor electronic crime fighter kiosks were unveiled on July 3, 2014 and 100 units were quickly installed in county buildings and businesses throughout Marion County.

THE FOLLOWING RESULTS HAVE BEEN PRODUCED AND CRIMINALS CAPTURED:

- **{July 11, 2014}** Within the first 2-days of roll out, Marion County captured the first felony fugitive after displaying his photo as a Wanted Person on a kiosk installed at a motel. A citizen recognized the fugitive and called a tip to the Sheriff's Office, who apprehended the wanted fugitive immediately.
- **{July 11, 2014}** A wanted felon saw herself on the Community Pro-Tektor located at a fast food restaurant and surrendered herself to the Marion County Sheriff's Office. She was wanted for felony fleeing and attempting to elude.
- **{July 16, 2014}** Marion County Sheriff's Office was working a death case with an auto theft. Community assistance was requested using The Community Pro-Tektor crime fighting kiosk in identifying a vehicle & suspects. Tips were provided within hours that directly led to the apprehension of the 3-suspects, who fled the State of Florida and were caught in Marion County, Alabama.
- **{July 17, 2014}** A sexual offender notification was displayed on The Community Pro-Tektor kiosks and the offender saw himself and called the Sheriff's Office and asked to be removed from the kiosks...he was unsuccessful.

At this point, we do not have a way to track exactly how many of these captures can be attributed directly to the Kiosk. This is in part due to how Crimestoppers handles the anonymous tips that they receive. What I can tell you is that when you do the math, 45 wanted fugitives have been placed on & removed from the Kiosk. 33 of those were captured and 12 were replaced by other wanted fugitives. Although I can't say for sure the exact success rate, I can definitely see through the eyes of nearly 20 years of Law Enforcement experience and tell you that these numbers are staggering. As Unit Commander for the Fugitive Apprehension Unit, I consider the Kiosk as one of my most valuable tools."
