1. I am the Secretary of Plank Law Firm, LPA.
2. On May 1, 2017, I was asked to locate a book to borrow called The Latest Illustrated Book of Development Definitions for Attorney Christopher Kessler's reference.
3. I searched The State Library of Ohio website (OhioLINK) and found the book only at Miami University and Ohio State University ("LIB USE ONLY") and at Ohio University ("AVAILABLE") and University of Cincinnati ("MISSING").
4. On May 1, 2017 (Monday), I called the Ohio State University Architecture Library Reference Department and asked if I could use my State Library of Ohio card to access the book at OSU. I was told the library is on "lockdown" due to final exams but, as of Wednesday, I could use my card and access the book to make copies of pages.
5. On May 2, 2017, I chatted online with Digital Downloads, linked from the Columbus Metropolitan Library website. I was told "It looks like there is a 2015 copy of this title, but I don't see any public libraries that own it, unfortunately. It does seem completely restricted to academic or specialized libraries. Columbus is the only library that owns in Ohio. But there are other libraries as well if you do a search on Worldcat.org."
6. On May 2, 2017, I searched Worldcat.org and found the book listed at the locations in item 3, as well as: Cleveland Public Library and Ball State University Library in Indiana.

1123.01 DEFINITIONS GENERALLY; INTERPRETATION.

(a) Words not particularly defined herein, shall be defined as found in The Latest Illustrated Book of Development Definitions, 2004, by Harvey S. Moskowitz and Carl G. Lindbloom, published by Rutgers University. Words not particularly defined therein shall be defined as found in the Dictionary of Architecture and Construction, 2006, edited by Cyril M. Harris, published by McGraw Hill. Words not particularly defined therein shall be defined as found in Webster's New Universal Unabridged Dictionary.

(b) Except where specifically defined herein, all words used in this Zoning Ordinance shall carry their customary meanings. Words used in the present tense include the future; the plural includes the singular; the word "lot" means the word "plot"; the word "shall" is intended to be mandatory; "occupied" or "used" shall be considered as though followed by the words "or intended, arranged or designed to be used or occupied".
