ITEM - From the Director of City Engineer

1. Sycamore Run Stream Restoration-Conservation Easement

Priestas has one item; request to grant conservation easement for Sycamore Run stream restoration, located on the east side of East Johnstown Road across from Crossing Creek South; was completed in fall 2014; Environmental Protection Agency 319 grant funded it; the vegetation and stream habitat have started and can now give Franklin Soil and Water Conservation District the easement.

1. Fleet Replacement Program

Franey said in the past we have appropriated funds for equipment replacement in account 5512 titled Capital Equipment; years ago Service began a program for equipment replacement; created account 5515; over the years have been selling vehicles at auctions; that money is given to divisions to spend first before allocated money each year; want to shift all of the monies into the 5515 account for an easier search with the extensions; not asking for additional funds, just requesting to transfer existing funds to new expense accounts.
