PARCEL ONE:

Situated in the State of Ohio, in the County of Franklin and in the City of Gahanna:

Being all of Lot 17 of "THE INDUSTRIAL ZONE," of record in Plat Book 54, Pages 86 through 90, inclusive, of the Recorder's Office, Franklin County, Ohio.

PARCEL TWO:

Situated in the State of Ohio, County of Franklin, City of Gahanna, being located in Section 3, Township 1, Range 16, United States Military Lands, and being 0.890 acre of the 1.349 acre tract conveyed to Leonard D. Myers, by deed of record in Deed Book 3620, Page 199, all references being to records in the Recorder's Office, Franklin County, Ohio, and bounded and described as follows:

Beginning at an iron pin at the southeasterly corner of said Leonard D. Myers 1.349 acre tract, said iron pin also being the northeasterly corner of Lot No. 18 and an angle point in the westerly line of Lot No. 17 of "THE INDUSTRIAL ZON," as the plat of same is of record in Plat Book 54, Pages 86 through 90, inclusive;

thence along the northerly line of said Lot No. 18, WEST, 235.00 feet to an iron pin at the northwesterly corner of said Lot and being in the easterly line of Lot No. 12;

thence along the easterly line of said Lot No. 12, NORTH, 165.00 feet to an iron pin at the northeasterly corner of said Lot, the southeasterly corner of Lot No. 15;
