H. OFFICIAL REPORTS

Assistant City Attorney

Roth said the Board of Zoning & Building Appeals (BZBA) hearing is tomorrow night, January 26, 2023 for the Sheetz appeal. Roth is representing the Commission and will be making an argument stating the reasons that were given on the records for the application being denied by this Commission.

Shapaka asked if the Commission attends the hearing, could they be called to speak on the matter. Roth shared that City Attorney Mularski's opinion is that BZBA rules say new exhibits can be entered that were not part of the record; it is a grey area whether testimony can be taken. He thinks they will just do arguments from councel. He does know that BZBA requested the Commission to be present. He assumes they could ask questions of the Commission if they wanted too.

Suriano recalled that application being appealed for Sheetz is a Conditional Use. If the appeal is won, does the application go forward to Council? Roth said if the Planning Commissions decision is overturned the Conditional Use is granted. The other two applications that were not originally heard would then come back to this Commission.

Director Blackford said historically at BZBA hearings they have asked a member to speak.

Blackford said that the Mighty Lion Car Wash has submitted a Design Review application. Previously their Design Review application was approved with the condition that they paint the color of the vacuum stations and pay stations to be consistent or complementary with the exterior colors of the building. They have not done this and submitted a new application not to paint.
