Three (3) xTrakker licenses will reside on customer's existing xT911 call taking workstations.

Two (2) xTrakker licenses will reside on customer provided workstations not equipped with xT911.

All xTrakker displays may be enabled to display CAD and AVL events.

xTrakker map display may be cloned and the cloned map displayed on additional desktop monitor, large wall monitor, projected image, etc.

The proposal further includes no more than -2- individual single work day trips by microDATA support technicians for any necessary onsite xCAD xAVL support and configuration efforts.

No custom microDATA programming is associated with this quote.

Without limiting any other responsibilities of City of Gahanna hereunder, the City of Gahanna is responsible for:

1. Coordinating cooperation with all relevant third-party vendors, ALI service providers, WAN vendor, Telco, to include any associated costs.
