A. CALL MEETING TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Gahanna City Council met in Regular Session on Tuesday, February 19, 2008, in Council Chambers of City Hall, 200 South Hamilton Road, Gahanna, Ohio. President of Council Nancy McGregor called the meeting to order at 7:30 p.m. Vice President Evers delivered an Invocation, followed by the Pledge of Allegiance led by Boy Scout Troop #766 Senior Scout.

C. HEARING OF VISITORS:

Jed Morrison, Superintendent, Franklin County Board of Mental Retardation and Developmental Disabilities stated I appreciate the opportunity to come and speak about Issue 29 on March 4 ballot; asking for support for continued services for children and adults who have mental retardation in our community; have good relationship with Gahanna; appreciate support from community; this levy will replace 2 levies; have one passed in 1980s for 1.56 mils and one passed 1998 for 2.32 mils for 3.97 total mils; this will replace them with 3.5 voted mils; when a levy is replaced, you replace at upgraded property values; the cost to homeowner of a \$100,000 home would be less than \$1/week; on the ballot it will look like a 1.65 mil replacement with increase of 1.85; if this passes we will drop the 2.32 mil levy; some of the services we provide are early childhood services, schools for children with multiple disabilities, 4 sheltered workshops like ARC Industries East on Taylor Station; also provide a variety of special services like the Special Olympics, transportation, living support, physical, occupational and speech therapy; have not been on ballot for 7 years; don't anticipate being on the ballot again until 2012 when another levy expires; thank you on behalf of our employees.

McAlister asked are we as Franklin County residents soley responsible for funding the MRDD. Morrison stated we receive a significant amount of state and federal funds; have been aggressive about drawing down federal funds. McAlister asked what percentage is federal money. Morrison answered local money represents 70% and state and federal is about 30%; in addition to that, majority of federal money is paid directly to providers. Evers stated there was a great article in the Columbus Dispatch about the levy and services you provide; impressed that you have been able to maintain cost structure while increasing number of people you're serving. Morrision stated it is the federal money allowing us to do that; thank you.

Mayor Stinchcomb presented Proclamation honoring Domenik Hixon and his family; said this is the first time we've had a member of the football team that won the Super Bowl in Council Chambers. Hixon thanked God for everything that He's placed in my

life; it has been a pleasure hearing all the support that Gahanna has provided me and my family; this is truly an honor; thank you for having me.

Charlie Wise, Representative, Gahanna Jefferson Board of Education stated had State of Schools on Feb. 4; presentations on different curriculum given; barring any unforseen catastrophes, we can extend levy; hired John Snoad from Napoleon High School as new football coach; came out of 68 applicants; approved additional dollars to help purchase new sound system in Gahanna Lincoln Auditorium; approved purchase of 3 new school buses; 20 new buses total; had some on the road since 1987; report on school closing criteria was given; is a process that we don't take lightly; not only do we report it to news and radio, is immediately on the Internet; on March 1st, Gahanna Excellence in Education program held at Creekside Events Center; Student Goverment Day is April 23 with Yvette McGee Brown as speaker.

their own zoning district; was a City initiative; did not want to do it all at once; many of these institutions did not have appropriate legal descriptions; down to last 4; Shepherd Church is on 36.15 acre lot and it's current zoning is SF-3, Single Family Residential and ER-1, Estate Residential; asking that this be rezoned to RID by City of Gahanna; has gone to Planning Commission and their recommendation is that we rezone it.
