#### ADDENDUM TO EXTEND THE AGREEMENT FOR AN ADDITIONAL PERIOD

This Addendum to Extend the Agreement for an Additional Period ("Addendum") shall be attached to and made a part of the Service Agreement for Administration of a Claims Program that was effective March 1, 2011 between City of Gahanna ("Client") and Sedgwick Claims Management Services, Inc. ("Sedgwick") (the "Agreement").

In consideration of the Agreement recitals and the mutual covenant and conditions contained herein, the Parties acknowledge that the Agreement is hereby amended as follows:

- 1. The Agreement shall be extended for an additional period commencing January 1, 2022 and ending December 31, 2024.
- 2. Section 9 of the Agreement is amended to modify Sedgwick's contact information to the following:

- 3. Client shall pay Sedgwick the following fees on a life of contract basis for services provided during this additional period:

### A. Claims Administration Fees:

i. January 1, 2022 and ending December 31, 2022:

ii. January 1, 2023 and ending December 31, 2023:

Self-Insured WC Flat Fee: \$13,921

State Fund Flat Fee: \$418

iii. January 1, 2024 and ending December 31, 2024:

Self-Insured WC Flat Fee: \$14,130

State Fund Flat Fee: \$424

### **B.** Miscellaneous Charges:

- i. January 1, 2022 and ending December 31, 2022:
  - a. ViaOne access, which includes two (2) view users and one (1) query user, is included in the claims administration fee. Additional access is available for a fee of \$342 per view user per year and \$1,714 per query user per year.

- ii. January 1, 2023 and ending December 31, 2023:
  - a. ViaOne access, which includes two (2) view users and one (1) query user, is included in the claims administration fee. Additional access is available for a fee of \$349 per view user per year and \$1,748 per query user per year.
- iii. January 1, 2024 and ending December 31, 2024:
  - a. ViaOne access, which includes two (2) view users and one (1) query user, is included in the claims administration fee. Additional access is available for a fee of \$354 per view user per year and \$1,774 per query user per year.

# E. Subrogation and Other Recoveries:

i. Sedgwick shall pursue recoveries for subrogation, second injury funds, and other applicable special funds such as supplemental state funds, COLA reimbursements, retro funds, and other similar funds. Client shall pay Sedgwick twenty percent (20%) of the

recovery received. All fees and expenses, including attorneys' fees or investigations, for pursuit of any recovery shall be charged to the appropriate Qualified Claim file as an allocated loss adjustment expense.

- ii. As determined by the parties, Sedgwick shall either:
  - a. Deposit the recovery funds and issue payment from Sedgwick's accounts Payable system to Client for the net recovery (less Sedgwick's fee). Sedgwick will deposit the net recovery check into the Client's loss-funding account or forward it directly to the Client.
  - b. Deposit the recovery funds into the Client's loss-funding account and Sedgwick shall receive payment from the claim file or directly from Client.
- 4. All terms and conditions of the Agreement shall otherwise remain the same, except those terms and conditions which have been added, deleted, or modified by the parties in writing.
