AN ORDINANCE AUTHORIZING THE MAYOR TO PROVIDE CONSENT AND ENTER A PARTICIPATORY AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION FOR BRIDGE REPLACEMENT ON WYNNE RIDGE COURT

WHEREAS, the City of Gahanna and the Ohio Department of Transportation (ODOT) have been working jointly on plans for a bridge replacement project on Wynne Ridge Court over Beem Ditch; and

WHEREAS, as part of this partnership, ODOT requests that the City pass legislation pledging its commitment to participate financially; and

WHEREAS, the local share will be responsible for five percent of the project cost, plus 100 percent of anything over the project cap of \$1.8 million; and

WHEREAS, funding is planned as part of the 2025 Capital Budget request to align with ODOT's planned construction schedule, which is slated to commence in the summer of 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to provide consent and enter into a participatory agreement with ODOT for the Wynne Ridge Court bridge replacement (FRA-Wynne Ridge Court; PID 116417); said consent legislation and project more particularly described in EXHIBIT A attached hereto and made a part herein.

Section 2. That this Ordinance shall be in full force and effect after passage by this Council and 30 days after signature of approval by the Mayor.

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above-described project as follows:

The LPA will be responsible for 5% of the project cost, plus 100% of anything over the project cap of \$1.8 million.

The LPA further agrees to pay One Hundred Percent (100%) of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the Project.

The LPA further agrees that change orders and extra work contracts required to fulfill the construction contracts shall be processed as needed. The State shall not approve a change order or extra work contract until it first gives notice, in writing, to the LPA. The LPA shall contribute its share of the cost of these items in accordance with other sections herein.

SECTION IV - Maintenance

Upon completion of the described Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the described Project in accordance with all applicable state and federal law, including, but not limited to, 23 USC 116; (2) provide ample financial provisions, as necessary, for the maintenance of the described Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.
