# ACTION ITEM #5: AMENDMENT TO RES-0013-2025 2026 SIDEWALK MAINTENANCE PROGRAM AREA RESOLUTION OF NECESSITY



The Department of Engineering previously received approval for the 2026 Sidewalk Maintenance Program Area. This program area defines the properties that will be part of Gahanna's Sidewalk Maintenance Program. After performing inspections and additional interdepartmental collaboration, the Department recommends that the 2026 Program Area be revised to the following streets:

## Removing the following streets:

- Caroway Blvd (Harrow Blvd to Helmbright Dr)
- Crystal Cay Ct (Woodside Meadow Pl to end of court)
- Moorfield Dr (Amfield Ct to Dunchurch Rd)
- Pond Hollow Ln (Harrison Pond Dr S to Harrison Pond Dr N)
- Woodside Meadow Pl (N Stygler Rd to end of court)

## Adding the following streets:

• Hines Rd (McCutcheon Rd to Gahanna Highlands Dr)

The revised Program Area can be visualized on the attached map and listing of the properties. The revised 2026 Program Area includes 30 parcels.

Upon approval of the 2026 Sidewalk Maintenance Program Area, an inspection program will be completed for the purpose of maintaining those areas in a good and orderly state of repair to protect the health, safety, and welfare of the public. Property owners within the program area whose sidewalks are in need of repair or replacement will be mailed a notification indicating the sidewalk deficiencies found, the estimated cost to be assessed as part of the Sidewalk Maintenance Program.

### **RESOLUTION OF NECESSITY**

The Department of Engineering is seeking approval for the 2026 Urban Paving Sidewalk Maintenance Program area. The program area defines the properties that will be a part of Gahanna's maintenance program in preparation for future street maintenance repairs in collaboration with ODOT under the Urban Paving Program. Based on the limits of the street maintenance repairs, the Department identified the 2026 Urban Paving Program Area to include residential properties along the following streets:

- Hamilton Rd (corporate limit southern boundary to Granville St)
- Granville St (Hamilton Rd to Lincoln Circle E)

This Program Area can be visualized on the attached map. The Department also has provided a listing of each property within the area. The recommended 2026 Urban Paving Program Area includes 32 parcels.

Upon approval of the 2026 Urban Paving Sidewalk Maintenance Program Area, an inspection program will be completed for the purpose of maintaining those areas in a good and orderly state of repair to protect the health, safety, and welfare of the public. Property owners within the program area whose sidewalks are in need of repair or replacement will be mailed a notification indicating the sidewalk deficiencies found, the estimated cost to be assessed as part of the Sidewalk Maintenance Program, and information on how to opt-out of the Sidewalk Maintenance Program.
