## **0.274 ACRES**

thence North 89° 44' 00" East, with the centerline of said Morse Road, a distance of 1903.12 feet to a railroad spike at the northeasterly corner of that tract as conveyed to The New Albany Company of record in Official Record 16769B08, at the True Point of Beginning for this description;

thence North 89° 44' 00" East, continuing with said centerline, a distance of 238.68 feet to a railroad spike found at the northwesterly corner of that tract of land as conveyed to Jack L. and Bonnie L. Evans of record in Official Record 2349111 and Official Record 2349113;

thence South 00° 00' 48" West, with the easterly line of said Evans tract, a distance of 50.00 feet to an iron pin set;

thence South 89° 44' 00" West, across said Underwood tract, a distance of 238.66 feet to an iron pin set in the easterly line of said New Albany Company tract;

thence North 00° 00' 30" West, with said easterly line, a distance of 50.00 feet to the True Point of Beginning and containing 0.274 acre of land, more or less.


