This letter shall formalize the easement acquisition by the City of Gahanna (City) over properties currently held by the Columbus Academy Schools (Academy). As you are aware the acquisition of a water line easement by the City was necessary to complete a much needed water line installation along Cherry Bottom Road. The City and the Academy agreed upon terms for the acquisition. The purpose of this letter is to further memorialize those terms.

The easement acquisition contained approximately 2.7 acres. In consideration of granting an easement to the City to place, maintain and repair a water line adjacent to Cherry Bottom Road, the Academy has agreed to accept compensation in the amount of twenty-thousand dollars (\$20,000.00). The City has agreed to install an 8-inch tee end valve to be placed on the water line. Both parties have agreed the tee end valve will be used, if at all, exclusively for fire protection purposes. Actual location of the valve will be coordinated with the Academy during the design phase of the project. The City has further agreed to waive all increased capacity assessments associated with installation of the 8-inch connection.
