Beginning in the easterly right-of-way line of Goshen Lane, at the northwesterly corner of said Lot 202;

thence easterly along the northerly line of said Subdivision, North 89°40'22" East, 453.95 feet to the northeasterly corner of said Lot 184;

thence SOUTH along the line common to Lots 166 through 173 and 177 through 184, inclusive, 599.13 feet to the southerly corner common to said Lots 173 & 177, being in the northerly line of Lot 175;

thence WEST, along the line common to said Lots 175 & 177, a distance of 45.00 feet to the northerly corner common to said Lots 175 & 176;

thence SOUTH, along the line common to said Lots 175 & 176, a distance of 112.36 feet to the southerly corner common to said Lots, in the northerly right-of-way line of Denison Avenue;

thence generally in a westerly direction along said northerly right-of-way line of said Denison Avenue, being the southerly lines of said Lot 176, vacated Wittenberg Street, Lot 193 & 194, the following five (5) courses and distances:

- 1. WEST, 79.00 feet to a point of curvature;
- 2. North 45°00'00" West, 15.71 feet along the arc of a curve to the right (Radius = 10.00 feet, Delta = 90°00'00") a chord distance of 14.14 feet to the point of tangency of said curve;
