RE: Proposal for Price St. 6" Waterline Engineering Design Services

Dear Mr. Weatherholt:

GGC Engineers, Inc is pleased to submit for your consideration this proposal for professional engineering services for a survey, design, bidding and construction inspection/administration for the proposed new 6" waterline extending approximately 1,470 feet east on Price Rd. from the intersection of James Road and Price Road.

We propose to provide professional engineering services to the City of Gahanna, OH, (herein referred to as the "Client"), in accordance with the terms and conditions set forth herein.

## **SCOPE OF SERVICES**

#### Field Survey

In order to assist the Client in obtaining a field survey for approximately 1,470 L.Ft. of proposed new 6" waterline south on Price St. from the intersection of Price and James Roads, GGC will provide the following services;

- 1. The proposed new 6" waterline project survey will consist of the following:
  - a. Provide a survey baseline, with reference survey ties, for the entire approximately 1,470 L.Ft. All baseline control points will be established within the field and they will be identified with a stake and survey ribbon.
  - b. Location of all existing utilities that will include utility type, location, and, if possible, depth.

- c. We will provide the Client with a copy of all of the surveyed field points. This field point file will contain each point number, easting, northing, elevation, and its description.
- d. We will provide a listing of all benchmarks utilized.
- e. Location of all encountered property pins and a listing of all permanent parcel numbers and the current permanent parcel's owner.
- f. The location of all existing structures encountered upon the proposed waterline's alignment.
- 2. Preparation of the proposed  $6^{\circ}\varnothing$  waterline plan and profile sheets and project specifications.
- 3. Regulatory liaison services with OEPA and City of Columbus permit application preparation.
- 4. Bidding Services to consist of providing technical specifications and mylar prints to you for City of Gahanna reproduction and distribution, attendance at a pre-bid meeting with prospective bidders.
- 5. After completion of the project, we will provide the Client with a copy of the entire survey and design on a CD-ROM formatted for AutoCAD LT usage. The CD ROM will be supplemented by 24" X 36" mylar plan and detail sheets.

We will complete the surveying and design tasks within 60 working days, after receiving written authorization to proceed.

### Information/Services Provided by the Client

The Client shall provide the following information and services to GGC:

- a. Access to the survey site during normal working hours.
- b. Provide a City employee for the first day of field survey; in order to interface with all affected residents.
