unregistered. Rather than issue a credit for water lost from the leak and

then bill for estimated water used, the

Board determined the best solution was to make no modification on

behalf of the Condo's or the City.

Current water use indicates there may still be a small leak. If this leak is located and repaired they can re-

apply for an adjustment back 1 year

from the date of their application.
