Subject: Appeals Request for Notice of Defects (Sidewalk Repair) Gah. Code §903.4

We are writing to formally appeal Gahanna City's request that we, as the property owners at 620 Codrington Circle, repair the sidewalk adjacent to our property. With the exception of #11, which we agree is in need of repair, all of the other parcel reports are trivial. We understand and appreciate the city's commitment to maintaining safe and accessible walkways, but we believe this request should be reconsidered for the following additional reasons:

- 1. Ownership and Responsibility:** The sidewalk in question lies within the public right-of-way and is used by the general public. As such, we respectfully contend that its maintenance and repair should be the financial responsibility of the city, not the adjacent property owner.
- 2. Condition and Cause:** The "damage" appears to result from general wear and tear/slow settling into the earth rather than any action or neglect on our part. *Candidly, the alleged "damage" is not significant enough to be in need of repair at this time* (with the exception of #11). Please see the supplemental pages for specific explanations for each claim.
- 3. Financial Burden:** The cost of sidewalk repair is substantial for our middle-class family with 3 young children. Requiring individual property owners to bear this expense is inequitable—especially when the sidewalks serve as shared public infrastructure. We consistently vote in favor for levies and taxes for our city, and this should be covered as part of it.

We respectfully request that the city review this matter to recognize that all of these proposed repairs (again, with the exception of #11) are unnecessary. If the city determines these are non-negotiable, then they should assume full fiscal responsibility for the repairs. We would appreciate written confirmation of the outcome of this appeal.

Thank you for your time and attention to this matter. We value the city of Gahanna's efforts to maintain safe, walkable neighborhoods *within reason* and hope that we can reach a fair resolution.




Sidewalk Maintenance Parcel Exhibit

This is actually more than a “minor” issue, compared to the other ones also labeled as “minor.” We agree this should be repaired.



This is incredibly minor, again, not at all a hazard. There is (and has been since we've lived here) a permanent black material/filler in this gap to avoid any gaps for injury risk. We appeal to the city to withdraw this repair request.

E (Minor Vertical Offset)

This is incredibly minor, again, not at all a hazard. Just because there is a crack in the panel seam does not mean it is unsafe. We appeal to the city to withdraw this repair request.

F (Major Vertical Offset)

This is incredibly minor, again, not at all a hazard. Additionally, just because there is a crack in the panel seam does not mean it is unsafe. We appeal to the city to withdraw this repair request.
