2003 PERSONAL COMPUTER ACQUISITION PLAN SUMMARY

The Department of Information Technology is proposing a plan for the purchase of 35 new personal computers with the \$72,500 appropriated for this purpose. This plan includes a three phase rollout over the course of the year, utilizing DELL equipment.

PHASED ROLLOUT

The purpose of the phased rollout tied directly to staffing of the Information Technology Department. The goal is to install the new PCs as quickly as possible, however, limited staffing require time to process all of the new equipment. Rather then shelving all PCs until installation, a rollout phase will allow the PCs installed later to take advantage of advancing technology and lower prices.

The phases detailed below were determined by the IT Department based upon a needs assessment. The IT Department requires any requested changes to the schedule be brought to the Director of Information Technology for consideration. It is also requested that council members contact the Director of Information Technology if they would prefer their PC to be acquired in an earlier phase.

Phase One: To be performed as soon as possible.

THE USE OF DELL EQUIPMENT

The Department of Information Technology requests the use of DELL equipment, waiving the bidding process. The government pricing for PCs is very competitive, and the cost with using DELL equipment is very reasonable. The reasons for standardizing on equipment include some of the following:

- Common repair and upgrade parts, requiring fewer unused parts in inventory
- Top support from DELL, rather than from various vendors
- Bulk pricing discounts
- Common tools and hardware for IT support staff to remain current in
- Faster testing of organization wide applications due to reduced hardware models
