ACTION ITEM #1: ORDINANCE ACCEPTING DEED OF EASEMENT FROM CP CRESCENT, LLC ASSOCIATED WITH THE PIZZURO PARK WATERLINE IMPROVEMENTS

Public waterline improvements were previously installed in the area near Pizzuro Park and the Buckles tract (improvement ST-646). The easement for this work inadvertently was not recorded previously and must now be recorded in order to allow the City to operate and maintain public infrastructure and to allow further development of adjacent parcels.

An easement from property identified by Franklin County Parcel No. 025-013767-00, as more particularly described on Exhibit A, is necessary. The Department of Engineering respectfully requests that Council issue an Ordinance to accept this easement. A Waiver and Emergency are being requested to ensure that correct documentation is filed in light of ongoing development in the area.

The 2023 Street Program will consist of asphalt resurfacing, crack sealing, and street rebuilds on various streets. ACTION ITEM #3: HAVENS CORNERS ROAD WATERLINE REPLACEMENT (ST-1072) PERMISSION TO BID

The Havens Corners Road waterline replacement project consists of replacing approximately 3,300 feet of existing 12-inch water main located in the Havens Corners Road right-of-way between Oak Creek Place and Helmbright Road with new 12-inch pipe. This water main was installed in the early 1960's and experiences frequent breaks. The project will also include installing approximately 450 ft of new 6-inch water main to replace existing 2-inch waterlines on St. Stephens and St Martins Courts, which also have an extensive history of breaks. As part of these waterline improvements, a total of 10 new fire hydrants will be installed throughout the project area to replace 8 existing hydrants.

Although \$700,000 already has been appropriated for this project, additional funds likely will need to be requested when awarding the contract to fully cover construction costs as well as consultant fees for construction administration and construction inspection services.

ACTION ITEM #4: 2021 SIDEWALK MAINTENANCE PROGRAM – AWARD CONTRACT

The 2021 Sidewalk Maintenance Program consists of concrete sidewalk and curb ramp removal and replacement, sidewalk panel chamfer saw-cutting and other related work.

On December 22, 2022, bids were opened and reviewed. In total, the Department received five bids. The lowest bidder, Professional Pavement had an incomplete/non-responsive bid. The Administration recommends awarding the bid to Newcomer Concrete who was the second lowest responsive and responsible bidder. The Department is also requesting a 10% contingency to cover any unforeseen construction costs.

The Department respectfully requests legislation authorizing the Mayor to enter into a contract with Newcomer Concrete for the 2021 Sidewalk Maintenance Program. Per Section 4.14 of Gahanna City Charter, the 30-day referendum will not apply once the contract is awarded.
