ACTION ITEM #1: 2026 STREET & SIDEWALK PROGRAM ST-1122 – PERMISSION TO BID

The 2025 Street & Sidewalk Maintenance Program (TR-CM-01) will consist of asphalt resurfacing, curb repairs, crack sealing and micro surfacing, preservation treatment of selected streets, pavement markings, ADA ramp repairs/replacements, and sidewalk repairs. Automated optical pavement condition assessment technology has been utilized, which identifies maintenance needs for the streets. A map of the anticipated list of streets and associated maintenance is attached for reference. The intent is to bid the 2026 Street Maintenance Program and the 2026 Sidewalk Maintenance Program together. . Funding for this project was allocated as part of the 2026 budget process.
