Pursuant to Section 4303.26 of the Ohio Revised Code, the Division of Liquor Control has considered the report of the hearing examiner regarding the objection by Gahanna City Council to the issuance of this permit, together with all the documents and reports pertaining thereto.

The Division finds that the Gahanna City Council was unable to present sufficient evidence to show that the applicant is unfit to engage in the retail sale of alcoholic beverages or that the issuance of this permit would adversely impact the peace, sobriety and good order of the community.

Therefore, it is ordered that Gahanna City Council's objection be overruled and the processing of this New application continue.

Gahanna City Council has the right to appeal this Order to the Liquor Control Commission as provided in Revised Code Section 4301.28(B). If you wish to appeal this Order, <u>you must file an appeal within thirty (30) days of the mailing date of this Order with the:</u>
