The objecting legislative authority or institution must have designated witnesses present at the hearing to give relevant testimony regarding whether the applied-for application should be approved. For purposes of this hearing, the applicable county prosecutor or his or her designee MUST represent the county or any township located within the county, in which the county or township filed an objection. The chief legal officer of the objecting municipal corporation or his or her designee MUST represent the municipal corporation. This requirement is mandatory.

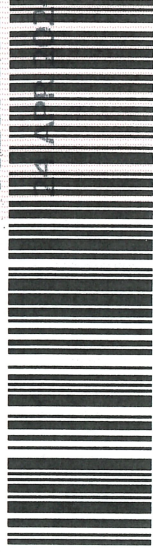
