ACTION ITEM #2: HAVENS CORNERS ROAD WATERLINE REPLACEMENT (ST-1072) AWARD OF CONTRACT AND SUPPLEMENTAL APPROPRIATION

This project consists of replacing approximately 3,300 feet of existing 12-inch water main located in the Havens Corners Road right-of-way between Oak Creek Place and Helmbright Road with new 12-inch pipe. This water main was installed in the early 1960's and experiences frequent breaks. The project will also include installing approximately 450-ft of new 6-inch water main to replace existing 2-inch waterlines on St. Stephens and St Martins Courts, which also have an extensive history of breaks. As part of these waterline improvements, a total of 10 new fire hydrants will be installed throughout the project area to replace 8 existing.

On March 9, 2023, construction bids were opened and reviewed. In total, three (3) bids were received. The lowest bidder, Dirt Dawg Excavating LLC, had a complete and responsive bid; the Administration recommends awarding Dirt Dawg Excavating the construction contract for this project.

A total of \$933,322 has previously been appropriated for construction. Based on Dirt Dawg's low bid pricing of \$1,163,481.75 and including an additional 10% for contingency, \$346,508 in additional funding is being requested to cover construction costs. Because of unforeseeable cost escalations, the Department of Engineering respectfully requests a supplemental appropriation in the amount of \$346,508 from the unappropriated/unencumbered balance of the Water Capital Fund to 652.11.000.5505. The request for additional funding will cover increased construction costs due to inflation.

The Department respectfully requests legislation authorizing the Mayor and Director of Engineering to enter into contract with Dirt Dawg Excavating LLC for the Havens Corners Waterline Replacement project.
