A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Gahanna City Council met in Regular Session on Monday, June 16, 2008, in Council Chambers of City Hall, 200 South Hamilton Road, Gahanna, Ohio. Vice President of Council Thomas C. Evers called the meeting to order at 7:32 p.m. Council Member Anderson delivered the Invocation followed by the Pledge of Allegiance. Agenda for this meeting was published on June 13, 2008.

B. ADDITIONS OR CORRECTIONS TO THE AGENDA: None.

C. HEARING OF VISITORS:

Bunnie Geroux, 306 Worman Drive, here today to give you a look at the day to day operation of the Herb Center; under the umbrella of Parks & Recreation for about a year now; rough and tumble in the beginning but going smooth now; gave you all a copy for the report; detail some highlights; with regard to special events, there was the DeMonye's luncheon with herbal demonstrations; was a 2 day event with over 100 in attendance; held a tea talk at Livingston House and assisted with details of the Creekside Grand Opening luncheon; held a tea at Gahanna Christian where talks were given on etiquette, tea purity and being young ladies, 27 teachers, mothers and daughters were present; attended Enrichment Day at Gahanna Lincoln Elementary where presented three short demonstrations to two classes on herbs and their uses; did a biblical herb talk at the Congregational Church on Havens Corners Road; trying to build interest at churches for having biblical herb gardens; Herb Day was very successful at Creekside; and Harvest Day is scheduled for Saturday, October 4th. With regard to tours in 2008, a group from all over was present on April 5, July 12 will be having Capital City Tours, on July 21, a local resident has a tour scheduled for 25 people, on August 30 AAA Tours from Cleveland will be here and on September 4 Experience Columbus. We had two interns begin the program in the fall from the Graham School in Clintonville; worked for 2 hours twice a week; constantly give unscheduled short demos and herb talks given regularly to Herb Center visitors; have had 2 rentals of the facility so far this year and have 3 upcoming; our classes are featured in the Gahanna Gateway program guide; have a great volunteer group with about 20 members with over 500 volunteer hours last year; 7 volunteers from Key Bank worked in the OHEC gardens for Make a Difference Day; several promotional features also; one with Midwest Airlines which will feature us in their fall publication; Cabot Cheese is donating 18 lbs of herbal cheese and all display items for Harvest Day; OHEC was showcased in the BIA magazine and herb gardens were included in many of the landscape designs for the Parade of Homes; have worked out a referral program with the OSU Department of Pharmacy for questions we get regarding medicinal uses for herbs; we have 5 herb gardens including the Sunburst Goosefoot at Creekside, the Herb Garden in the High School Courtyard, the Historical Society Goosefoot, the Geroux Herb Gardens at City Hall, and the Ohio Herb Education Center Gardens. In response to question from Anderson, Geroux stated if people call with questions regarding medicinal uses for specific diseases, can refer them to OSU School of Pharmacy; not allowed to tell people; was a wonderful thing when we could finally make that reference. Samuel asked how people found them. Geroux stated Collins is working on getting them a sign; that will help tremendously. Evers thanked Geroux for all she does; thank you for your report.

F. PUBLIC HEARINGS:

Z-0009-2008

Z-0009-2008 To consider a zoning application to change this property to add a two story therapy room to the existing nursing home; current zoning L-SO; requested zoning L-SO which requires a change to previously approved plans; located at 167 Stygler Road; National Church Residences; George Berardi, applicant.

Sadicka White, Director of Development, stated the application before you is for a zoning change for 167 Stygler Road, location is on west side of Gahanna just north of 62; particular application is for change from L-SO and going to L-SO; any time you want to alter in any way a limited overlay, it is tantamount to a rezoning; asking for the same classification; changing a portion of the building is the reason for the application; surrounding area is multi family, CC and SO which would allow for this kind of use; the applicant is adding to the current facility by adding a two story addition on the north side of the building that would allow for them to expand their therapy room; this is one of their facilities that offers skilled care as well as long term care in our community; this application has been recommended by Planning Commission; this is the second time around; met with affected property owners; received a recommendation for the zoning change by the Planning Commission; complied and comported with appropriate screening and landscaping for the west use; concludes my report on behalf of the administration.

Vice President opened the public hearing at 7:49 p.m.

George Berardi, 369 E. Livingston Avenue, stated he was representing National Church Residences; worked through this application with Planning Commission and neighbors; really have made changes which support the expanded need for this facility; one of the things that happened previously is that we were developing a stand alone addition which started to encroach on some of the personal space for the neighbor to the north;

worked with members of Council and north property owner to develop what we consider a better plan; this is 5,000 sf but takes a footprint of about half of previous application; will convert some interior space to therapy space; still need around 4,000 sf; will be moving some residents to second floor of this addition and expansion of therapy space on first floor; part of the reason for the need is growth in this industry; we need this for our own campus; will also be providing some services on outpatient basis, our residents on campus include Stygler Commons and Stygler Village and really are in need of more therapy; we couldn't provide that support; this will help us to provide our own campus without having to send them to some outpatient therapies; worked with Council representative and neighbor to north; now expanded to a substantial setback; consider looking at this as a two story building; fits much better with the character of the building; all the materials will match the existing facility.
