<u>ACTION ITEM # 1 – ORDINANCE TO AUTHORIZE THE MAYOR TO ENTER INTO EASEMENT AGREEMENT WITH COLUMBIA GAS OF OHIO</u>

Columbia Gas of Ohio, Inc. is proposing a pipeline replacement project known as the NCHP Pipeline Project. The proposed pipeline will install approximately 19,000 feet of 24-inch diameter pipeline through the City of Gahanna. Columbia Gas will likely begin field construction in 2026.

Columbia Gas of Ohio requests an easement for permanent right of way for the purpose to construct, maintain and operate a lateral pipeline. The requested easement will traverse multiple parcels (025-000876, 025-012061 and 025-012951) within City of Gahanna parkland. The value of the easement is outlined in the attached supplemental agreement.

The Administration respectfully requests an Ordinance to authorize the Mayor to enter into as easement agreement with Columbia Gas of Ohio. Upon acceptance, the easement will be recorded with the Franklin County Recorder.

ACTION ITEM # 3 – ORDINANCE TO AUTHORIZE THE MAYOR TO ENTER INTO AN ACCESS AND GENERAL UTILITY EASEMENT WITH COLUMBIA GAS OF OHIO

Columbia Gas of Ohio, Inc. is proposing a pipeline replacement project known as the NCHP Pipeline Project. The proposed pipeline will install approximately 19,000 feet of 24-inch diameter pipeline through the City of Gahanna. Columbia Gas will likely begin field construction in 2026.
