Ewald said this language brought forward by Council made a request to put together language for 100% credit instead of reduced credit that we have currently; this automatically goes into effect should the income tax

increase pass on the ballot; would go into effect Jan. 1, 2019; legislation requires minimum of 3 public hearings; this is the 1st.

Leeseberg stated the rules of the public hearings and opened to the public.

Rick Duff, 312 Dunbarton Rd.; here to discuss Ord-65-18; opponent; not necessarily opponent of tax increase but opponent of the 100% credit; believes current rate is fair; believes we should be giving all our money to our local government, but that is a state issue that needs to be fixed; reading through language, has some concerns; would suggest that it be looked at by a few other legal experts; doesn't seem bulletproof in my opinion.

Leeseberg closed the Public Hearing after determining that there were no other opponents, proponents, or rebuttals.

Ewald said this was vetted by a tax law firm; agrees with Duff that this is something a tax professional needs to review; thanked Duff for his comments.
