Big Walnut Trail/Safe Routes to School Project Updates

- Big Walnut Trail Section 5: Preconstruction meeting last Thursday/Columbus Asphalt think they can finish the job on time, no big issues. Tom walked and stopped a few folks walking, who thought it was a great idea. Boardwalk may stay; Apt. complex may go in on near the Creekside/Golf Course Area.
- SRTS: Bulk of project is done, constructor is cleaning up. Reviewed some photos of the Cherrybottom and Heil Rd.
- Flint Ridge rebuild: Complete street rebuild, checked out pictures Kate took. City street improvements will all include sidewalks.
- Tech Center paint will go down soon. Bike path on Taylor/Tech Center fixed too.

Community Outreach ideas/discussion

- Council Communication Troy will automatically forward BTAC notes to council, parks board members for review on regular basis.
- Policy Example MVRPC, adopting a public participation policy asking for public input on draft plan. Reviewed the TOC. Service has their internal protocols based on grants/funding requirements. Service has standard practice to include public input in all their projects. No policy or standardization.
- TROY: BTAC Protocol for transportation projects and bike/ped projects putting together a protocol for public input and communication between city, committee, and public in a standardized format.
- ACTION: Distribute MVRPC Policy link to Committee to review. Discuss possible policy/protocol at next meeting.
- ACTION: BTAC Plans a couple public meetings in 2016 to gather info, impart and educate community. Other work besides BWT that could be addressed.
- Parks & Rec Levy starting petition campaign in next couple weeks to put on ballot for March 15, 2016. Citizens for Gahanna is a FB page.
- TOM: Feb/March public safety input process still with P&R staff, will share with Rob and report out at later date.
- TRICIA QUESTION: do other cities have a public input policy or process?

New Business

KATE IDEA: Advance bike parking with business community; request businesses and developers to consider adding to their properties. Kroger, Post Office, Library, New Hamilton Rd. retail.

Rapid Flashing Beacons to be located in Gahanna: New sidewalks/crosswalks by new park property started discussion on locations for RFBs for MORPC grant Rob is writing. Parks, schools, some church areas may be considered.
