City Attorney:

Weber stated they should know later this week the status of our referendum petitions on SB5; talked to Joyce Bushman; think they will still need another 50,000 signatures after first batch is certified; have 10 days after first batch is certified to get additional signatures; will keep you posted.

M. COUNCIL COMMENT:

Hogan stated they just got an ordinance tonight for the purchase of Janis' property; have been in contact with County Auditor's Office; my concern is that \$390,000 is approximately 3 times the appraised price; a box of Cheerios has a retail price of \$4; my wife just paid \$2 for this same box; if you ask anybody to pay \$12 for a box of Cheerios, they wouldn't buy it; why would you pay 3 times the appraised price; County Auditor's Office compiled a study in 1999 of all commercial and industrial properties sold in this area; the low selling price was \$13,000 per acre and it went up to \$340,000; this property is being proposed at \$40 a foot which compared to Cheerios would mean you weren't paying \$12 but \$15; going to committee next week for discussion; coming back on 17th for passage possibly; urge public to express views to Council; let us know what you think; if you think it's too much let us know; other than that have a great December; Holiday Lights was great.

O'Brien stated he wanted to thank all those in community for their thoughts and prayers recently; received many phone calls when we heard about the terrible accident Karen Woodward's son was in; believe in power of prayer and believe that worked last night; appreciate this community; when things like that happen we come together as a community family.
