FIRE DEPARTMENT UPDATES

Chief Kauser provided an update on fire operations from 9/20-10/21. Mr. Schnetzer asked what is the definition of a "working fire". Chief Kauser said sometimes we show up and pull off a fire extinguisher, there's some smoke; we have those every day. A working fire, we send 6 companies to fight the fire, it's a bad fire.

Mrs. Angelou asked what causes these fires. Chief Kauser said it's a combination of things. Most of the multi-family fires, if it's 20 years or older it doesn't have sprinklers, but the newer builds do. The key is early detection. Unlike 10 years ago, these are plastics, explosive fires. By the time the detector goes off, you're out of time. Early detection is key.
