



BUILDING AND ZONING FEE SCHEDULE

A fee is charged to recover the City's administrative costs for enforcement of codes related to building, development, electrical, plumbing, and mechanical permits and zoning applications and processing.

§ **THE 1%** Ohio Board of Building Standards (BBS) fees **SHALL BE INCLUDED** for all one, two and three family dwelling permits ~~shall be 1%~~ **APPROVED UNDER THE RESIDENTIAL CODE OF OHIO.**

§ **THE 3%** Ohio Board of Building Standards (BBS) fees **SHALL BE INCLUDED** for all commercial and multi-family buildings of four or more units ~~shall be 3%~~ **APPROVED UNDER THE OHIO BUILDING CODE.**
