

**PROPOSED ANNEXATION OF 1.8 ACRES**

TO: THE CITY OF GAHANNA

FROM: MIFFLIN TOWNSHIP AND JEFFERSON TOWNSHIP, FRANKLIN COUNTY, OHIO

Situated in the State of Ohio, County of Franklin, Township of Jefferson, being located in Quarter Township 2, Township 1, Range 16, United States Military Lands and bounded and described as follows:

Beginning at the southeasterly corner of Lot 5 of "Terry Acres" of record in Plat Book 24, Page 86, in the existing City of Gahanna Corporation Line as established by Ordinance No. 204-94 of record in Official Record 28267B19;

thence Westerly, with said City of Gahanna Corporation Line, a distance of approximately 424 feet to the southwesterly corner of said Lot 5, being in the existing City of Gahanna Corporation Line as established by Ordinance No. 99-358 of record in Instrument Number 199912020298510;

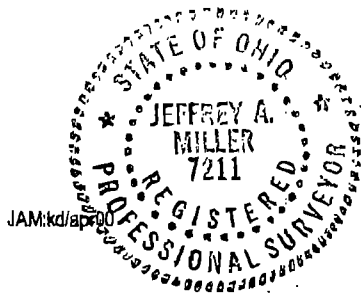
thence Northerly, with said City of Gahanna Corporation Line, a distance of approximately 180 feet to a point in the existing City of Gahanna Corporation Line as established in Ordinance No. 5-92 of record in Official Record 19210A12, being the northwesterly corner of said Lot 5;

thence Easterly, with said City of Gahanna Corporation Line, a distance of approximately 424 feet to the northeasterly corner of said Lot 5, at an angle point in the existing City of Gahanna Corporation Line as established in Ordinance No. 98-434 of record in Instrument Number 199903220070336;

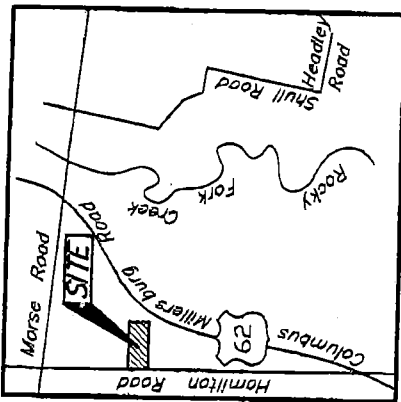
thence Southerly, with said City of Gahanna Corporation Line, a distance of approximately 180 feet to the point of beginning and containing approximately 1.8 acres.

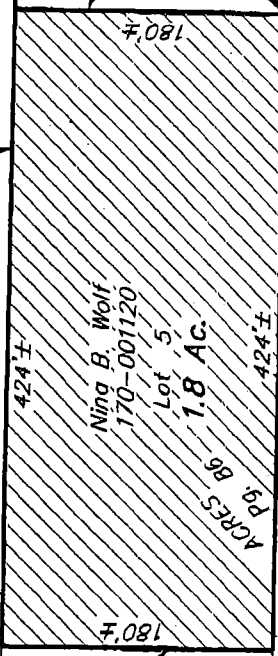

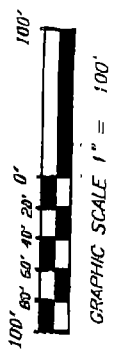
