A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call:

Gahanna City Council met in Regular Session on Monday October 4, 2010, at Gahanna City Hall, in Council Chambers, 200 South Hamilton Road. President Thomas R. Kneeland called the meeting to order at 7:30 p.m. Invocation was given by Council Member Shane Ewald followed by the Pledge of Allegiance. Agenda for this meeting was published on September 30, 2010.

B. HEARING OF VISITORS:

Kate Moening, Troop Leader, stated they were present to ask Council to proclaim Saturday, October 23 as "Make A Difference Day in Gahanna"; this is the 5th year in a row to ask for a proclamation; we feel strongly that giving back to our community is important; members of the troop related events they have participated in for Make A Difference Day in Gahanna over the last 5 years. Mayor Stinchcomb presented a proclamation for Make A Difference Day to Girl Scout Junior Troop #50354.

Sarah Goldberg, Life Care Alliance, 1699 West Mound St., Columbus, OH stated that Life Care Alliance is a private not for profit organization that provides a comprehensive array of health and nutrition services to older adults, chronically ill, and disabled central Ohioans; founded in 1898 as the Instructive District Nursing Association; it was the first in-home health care agency and Ohio's first Visiting Nurse Association; our mission is to lead the community in identifying and delivering health and nutrition services to meet the community's changing needs; we operate with a staff of approximately 230 and more than 6,200 volunteers; we assist residents in Franklin, Madison and Delaware counties through its signature programs - Meals on Wheels, Senior Dining Centers, Wellness services, Help-At-Home, Visiting Nurse Association, Columbus Cancer Clinic, Project Open Hand Columbus, and Groceries-to-Go; 71% of clients are female, 42% are minority, 62% are age 65 or older, and 65% have annual incomes of less than \$20,000; introduce to you Dan Marvin who is a Gahanna resident and has volunteered with us since 1994.

Dan Marvin, 1029 Sugar Hill Place, Gahanna stated that this work comes from his heart; have been a volunteer for 16 years; they are not clients, they are just friends; was a paramedic firefighter for 25 years but this is the best thing I have ever done; God is making me an instrument in this; it is absolutely the best thing I could ever do.

Goldberg continued that she had provided a packet of information on the services we provide in this community; go to our website at www.lifecarealliance.org if you might be interested in volunteering or just learning more about us; in 2009 we served over 15,000 clients and prepared over 1 million meals; proved 229,063 meals for children's after school and day care programs; logged 327,048 miles and 123,254 hours of service through 6,286 volunteers; this is just a few of the things we do; on October 17 there will be a fund raiser; all proceeds benefit LifeCare Alliance; recently had a story that aired on 10TV about the Gahanna Senior Center donating a quilt; provided you with a synopsis of that story;

Kneeland stated that this sounds like an awesome opportunity for the betterment of the community; get the word out about the services being provided if we don't already; appreciate all you do; easy to hear the conviction in your voice. Goldberg stated there was a fan drive this summer which resulted in over 200 fans being dropped off at Mifflin Township fire stations just from Gahanna residents; helped us to have no deaths in

central Ohio from heat related events. Kneeland stated this community is very volunteer oriented.

Stinchcomb stated there was a good turnout last Thursday; ODNR Director Sean Logan was here to present a check for \$439,137 for Recreational Trail Program and Clean Ohio Trail Funds; Representative Nancy Garland was present as well as Councilman Dave Samuel; special thanks to Kate Moening who writes our grants and the Parks & Recreation staff who work so hard to find and apply for these types of innovative funding sources for the City; members of the Parks & Recreation Board and the Foundation were also present.

Samuel noted the passing of a great citizen of Gahanna; - Dr. George Knox who was 99 years old; at age of 50 he had a serious heart attack and started running; he continued until he was 86; he won many national and international awards; passed at Chestnut Hill a few days ago.

Ewald noted that the Creepside Festival showed up on a MSN portal; thank whoever was responsible for that; second thing is to thank all our staff members; sometimes Council becomes entrenched in the budget and forgets the time involved in applying for grants etc.
