A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Gahanna City Council met on Monday, October 4, 1999, in Council Chambers of City Hall, 200 South Hamilton Road, Gahanna, Ohio. President of Council Robert W. Kelley called the meeting to order at 7:30 p.m. with an Invocation by Council Chaplain Debra A. Payne, followed by the Pledge of Allegiance.

B. ADDITIONS OR CORRECTIONS TO THE AGENDA. (None)

C. HEARING OF VISITORS

Executive Jet - Noise readings.

Richard G. Smith, III, a resident of Blacklick, and Gary P. Strapp, a resident of Gahanna, both representing Executive Jet, Inc., noted they were asked to respond to noise inquiries; in pursuit of this, arranged with Goshen Lane School to place a monitor on the top of that facility; they knew that to register 63.3 dB, the noise would have to last 11 seconds or higher. Said during the test there were airline arrivals and departures. They used the Falcon 2000, which is their largest, and ran both engines simultaneously for 5 minutes. Said the noise never exceeded 57 dB; said they did a take off and low approach, and neither registered; did a full stop, which was a full thrust burst.

Smith said they felt the test was very valid, and felt it proved they are going to be a good neighbor. Advised the residents did not hear a thing.

Payne thanked Smith and Strapp for allowing she and President Kelley to go out for the test. Kelley thanked them for the test. Angelou advised calling area residents and they were pleased; were listening on walk-talky communication; felt this is a positive thing; noted that at the beginning of the year there was an issue as to what these readings would be; felt the neighbors appreciated the testing.

Smith said if anything comes up, to please call; said they will do anything they can do.

School Board - Windy McKenna

Windy McKenna thanked Bob Kelley for coming to their meeting. Advised they were very proud of the outstanding math teacher award given to a Middle School East

teacher; said a co-winner was a teacher of that teacher's children in the Westerville system. Advised they started this year with 6800 students, which is the figure used by the State; noted also \$5,600 donated by prior classes to pay for the school sign. Advised also that they have a new grant writer on board. The board approved several construction contracts. Next meeting is Thursday, October 14.

Curtis Collins, F.B.I.

Curtis Collins of the F.B.I. said was at the meeting to make presentations to Chief of Police Dennis Murphy on the cooperation between the Gahanna Police Department and the F.B.I., and to take the opportunity to recognize the efforts of certain officers; said in a time when law enforcement takes so much of a hit from the media, it is nice to so do.

First, a bank robber by name of Ronnie Lee Hurd; robbed 2 banks in Gahanna and 3 in Columbus; was identified through investigation; said the focus of the investigation was that they were working together and the robber was identified; said a significant part of that was the Gahanna Police Department; also involved a night surveillance, and he was apprehended. Noted Officers Williams, McCormick, and Lloyd. The man was convicted of 3 of 4 robberies and was sentenced to six years in Federal Prison.

The second involved 3 banks, and amounted to \$90,000. The robber Curtiss Mann used firearms in 3 of those robberies; banks hit were: Key Bank, Star Bank, and Bank One. The quick response by Gahanna Police Department resulted in Mann being detained in his car; resulted in a high speed chase. Advised that Mann was convicted of 12 counts of robbery and sentenced to 55 years. Recognized the efforts of 3 patrolmen. Ben Corbin, Jeff Spence, and Dean Blamer.

Also read and then presented a letter to Chief Murphy recapping this recognition. Said the letter was signed by Louis Freed.

President Kelley thanked Collins for being present and for these recognitions.

Tim Pack, Academy Ridge Community Association

Tim Pack, 1019 Ridge Crest Drive, along with Mr. Rikoff of the association, was present to thank this body; said over the last year the association had worked very closely with the City on issues at Beecher and Hamilton; have been privileged to see workings of city government. Thanked Mayor Mc Gregor for all the close contact and work; all the work of engineer Karl Wetherholt for the traffic signal, noting there were a number of issues to be overcome; but, through diligence and determination, was able to get it done. Thanked city development office; said they got into several issues, and support they provided. Chief Murphy, noting there were a number of traffic issues. Appreciated that they were very supportive of us. Pack quoted Franklin D. Roosevelt, who had said "The hardest task if not doing what it right, but knowing what is right." Thanked Council members for their actions. Said as he had gotten into more issues in the association was surprised how many residents were long-term residents. Thanked for all their help.
