White said that Matt Huffman, Community Development Manager, would make a brief introduction. Huffman said after much work, working very diligently; trying to make sure all legal aspects were in order; working with Chris Miller and various providers; have an ordinance that staff feels is easily defensible and addresses the concerns of the providers for use for any wireless facility that may wish to come into Gahanna.

McGregor opened the public hearing at 7:40 p.m. and asked for proponents. Chris Miller, attorney Schottenstein, Zox and Dunn, said he has worked with staff to come up with a comprehensive wireless facility ordinance for the city; staff did a significant amount of work; went line by line; several drafts that were commented on by industry; reviewed a number of questions, comments and suggestions; balanced to protect the City interests with what would be complementary to the residents; modified drafts to make sense for Gahanna and what our capabilities are; keep the application fair to buyers and protect City interest; market changes so quickly need to catch up legally.
