<u>ACTION ITEM # 2 - Ordinance - Temporary Work at a Higher Classification</u> (<u>Director of Public Service and Engineering</u>)

The Director of Public Service and Engineering resigned from the City of Gahanna on May 21, 2019. Per Pay Plan Section 4(B)(8), the Administration respectfully requests Council to approve a supplemental request for temporary work out of class for Deputy Director of Public Service and Engineering Grant Crawford. Mr. Crawford's current hourly rate is \$40.56. The Administration does not intend to recruit for a Director of Public Service and Engineering due to the change in City leadership in January 2020. The total request for supplemental appropriation is \$3510.00, which will increase Mr. Crawford's hourly rate to \$44.00 for the remainder of 2019 (June 1 – December 31, 2019). This request is solely from the proprietary funds. No general fund dollars are being requested. As Interim Director, Mr. Crawford will be responsible for tasks listed in Chapter 135.01, Director of Public Service and 135.011, Deputy Director of Public Service. The increase in responsibilities warrant a pay increase for serving in a higher classification.
