Angelou stated they had received about 10 E-mails regarding Creekside; concerns on 3 of them that talk about secret meetings; ask President to poll Council to see if anyone

attended secret meetings; found it very objectionable; have served twenty years; understand the sunshine law; poll Council on who has actually attended secret meetings.

Stinchcomb polled Council as to whether they had attended secret meetings. Payne replied she had not. Kneeland replied he had not. O'Brien stated that would be a criminal act and he had not. Shepherd stated he had not. Angelou stated she had not. Hogan stated he had not. Stinchcomb stated she had not.

Angelou stated that another item that bothered her was that a few of the letters talked about the City pouring more money into Fire and EMS services; we do not provide those services; they are provided aptly by Mifflin Township

O'Brien stated he found it disturbing that those who may have an interest in running for Council don't realize that City Council does not fund Fire and EMS; did receive one letter besides the 10 E-mails that were sent.

Hogan stated that there were 15 total E-Mails; don't expect the public to understand or know who provides fire services; they look at it as the city is the city; how many times do they talk to us about the schools; think what is important is that we did receive these; people by and large are saying they like what we have but want to know what is being planned; noted E-mail and read portion from Joan Bouros; also read from Greg Higgins.

O'Brien stated we have read the E-mails. MOTION to proceed with the agenda. Hogan stated he found it interesting that 15 residents took time to write Council. MOTION was restated by O'Brien to move from this issued, and seconded by Payne. In response to question, Weber noted that the motion is in order if you wish to move on.

Payne stated the only reason voting for is that we haven't read every E-mail that comes to us publicly from the dais; if you want something on the public record you come to a meeting, fill out a speaker slip, and speak; when sent to us as E-mail, the correspondence is acknowledged but not read.

Stinchcomb stated she had concerns with the appropriateness of reading names on the public record.

ROLL CALL: Voting yes: O'Brien, Payne, Shepherd, Stinchcomb, Kneeland. Voting no: Angelou, Hogan. Motion carried.

Angelou stated she was responding to each E-mail received; think the one said there were only 2 of us who responded; is up to Council individually to respond; that is the magic of this technology; reading every one seems to be a little much; have no problem with putting them as part of the record.

Hogan is Council's prerogative to be receptive; every member of this Council has read correspondence they have received; hope Council is more open to setting up for public meetings in the school and in hearing the public; the E-Mail forwarded to us by Isobel and signed genjima is from General Abraham; have received these from all over the city; all basically like what we have done but have concerns with where we are going.

Angelou stated that one E-mail talked about not giving monies to the schools; note that there is \$1.5 million in next year's budget to pay the schools; \$855,000 was given to them in 2000 and \$1.3 million this year; is a large budget item.

#### L. OFFICIAL REPORTS:

Mayor

McGregor noted we haven't taken possession of Summerfield's yet; they have few weeks left; already have a restaurant interested in locating there; citizens committee will be looking at this as well as how to open to other proposals; that group of citizens and officials will make a decision; will be a wonderful addition after many years of having that key corner vacant and derelict.

**City Attorney** 

Weber stated he had called Governor Taft's office and asked them to veto the annexation bill

#### M. COUNCIL COMMENT:

Hogan stated there have been no secret meetings; however, have received confidential E-mails although it is public information; a response received from a Council Member to one of the E-mails was to come to committee meetings; can't tell you the number of times I have seen a committee chair say this is not the time for public comment, show up at a Council meeting; need to have more public input on the Creekside issue; last week Mayor stated he is following the fast track because Council passed a plan; Council passed a plan that calls for 300,000 sf of retail and 1000 new jobs; as part of the Planning Commission recommendation it was requested that an independent marketing study be done; that has not been done; was also stated that a traffic study should accompany this; voted for Stilson because it included a traffic analysis; reports from

Stilson will consist of 9 parts - a, b, and c gives us information; what it will cost, traffic count, and EPA effect on Clark station; after a, b, and c are completed, want Wetherholt to tell us it is done; want to have public meetings back out in schools after that is done; public needs more input; don't know what Phase 2 is; it can't pay for itself; that's the one thing I would ask we do; if any other developer had gotten his plan approved as we approved the conceptual plan and then eliminated as much as we have done, every member of this Council would say this is a substantial change that would have to go back to Planning Commission; we are buying properties and tearing down; are getting close to bricks and mortar; public has fantastic ideas that every member would benefit from; thank you very much.

McGregor stated we are not at bricks and mortar; this will have to go back through Planning Commission; is a whole lot of opportunity through the Planning Commission process for public input - architecture, construction, design elements; every aspect, even the landscaping, does need to be approved by the Planning Commission.

O'Brien noted that we are required to have public meetings; none of us disagree with that; think what Hogan wants to imply is that 6 members of Council would like to not have public meetings; that is not the case; challenge Hogan to be more concerned with education and not incitement; you are inciting the public; if they heard both sides of the story they would have a different feeling; your editorial was inciting and rude; was disrespectful to every member of this Council.

Shepherd stated he felt Hogan's article was irresponsible and immature.

Stinchcomb stated there was discussion last week about the Charter Review Commission recommendations; know there was some discussion about the Ward Council people having 4 year terms; my concern wasn't necessarily 4 years but the concern was for staggering the terms; important we do that; also do think 4 year terms would keep politics out for 2 more years and tonight's meeting is a testament to that.
