do es hereby Remise, Release and forever Quit-Claim to the said Grantee,
The Village of Gahanna, Ohio, its successors

XXXXXX and assigns forever, the following REAL ESTATE, situated in
the County of Franklin in the State of Ohio and in the
Village of Gahanna and bounded and described as follows:

Parcel No. 1

Beginning at an iron pin which is the southeast corner of Reserve B of Westergard Park Addition, as same is of record in Plat Book 22, Page 5, Franklin County Recorder's Office; thence along the south line of Reserve B produced, South 85° 53' East, 421.66 feet to an iron pipe near the west bank of Big Walnut Creek; thence South 7° 46' East, 140.72 feet to a point, which point is the true point of beginning and the northwest corner of the parcel to be conveyed by this instrument; thence North 60° 02' 30" East, to the center line of Big Walnut Creek; thence southeasterly along the center line of Big Walnut Creek to a point which is 105 feet south of the last described course as measured at right angles to the last described course; thence South 60° 02' 30" West, to a point which is 105 feet southeast of the above mentioned northwest corner of the parcel herein conveyed, as measured at right angles to the north line of said parcel; thence North 29° 57' 30" West, a distance of 105 feet to the point of beginning.

Parcel No. 2

Situate in the County of Franklin, State of Ohio, Village of Gahanna, and being a strip of land fifteen (15) feet in width across the 7.67 acre tract conveyed to the Jefferson Local School District Recreation Council by deed of record in Deed Book 2031, Page 236, Recorder's Office, Franklin County, Ohio, the center line of said strip being described as follows:

Beginning at an iron pin at the southeast corner of Reserve "B" of Westergard Park Addition, as the plat of same is shown of record in Plat Book 22, Page 5, Recorder's Office, Franklin County, Ohio;

thence along the north line of said 7.67 acre tract, South 85° 53' East, 421.66 feet to an iron pin near the west bank of Big Walnut Creek;

thence South 7° 46' East, 140.72 feet to a point, which point is the northwest corner of the tract to be conveyed to the Village of Gahanna for a pump station site;

EXHIBIT A

thence along the westerly line of said pump station site tract, South $29^{\circ} 57' 30''$ East, 79 feet to a point, which point is the true place of beginning for the center line of the easement herein intended to be described;

thence across said 7.67 acre tract, South $60^{\circ} 02' 30''$ West, a distance of 555 feet, more or less, to a point; thence South $2^{\circ} 09'$ East, a distance of 17 feet, more or less, to a point in the south line of said 7.67 acre tract, together with the right to use only during the period of construction, two (2) strips (twenty-five (25) feet in width), lying respectively immediately north of and parallel to and south of and parallel to the above described fifteen (15) foot permanent easement.

Parcel No. 3

Situate in the County of Franklin, State of Ohio, Village of Gahanna, and being a strip of land twenty (20) feet in width across the lands of the Jefferson Local School District Recreation Council, as conveyed to same by deed of record in Deed Book 2031, Page 236, Recorder's Office, Franklin County, Ohio, the center line of said strip being described as follows:

Beginning at a point in the westerly line of Reserve "C" of Westergaard Park Addition, as the plat of same is shown of record in Plat Book 22, Page 5, Recorder's Office, Franklin County, Ohio, which point is South $4^{\circ} 03'$ West, 10 feet from the northwest corner of said Reserve "C"; thence South $85^{\circ} 53'$ East, (parallel to and 10 feet southerly from the north line of said Reserve "C" and said line produced easterly) 485.69 feet, more or less, to the point of tangency of a curve to the right; thence along the arc of said curve (radius = 150 feet, delta = $55^{\circ} 55' 30''$, tangent = 79.63 feet), the long chord of which bears South $57^{\circ} 55' 15''$ East, 140.67 feet to the point of tangency of said curve; thence South $29^{\circ} 57' 30''$ East, 67.79 feet to a point, which point is North $60^{\circ} 02' 30''$ East, 10 feet from the northwest corner of the tract to be conveyed to the Village of Gahanna for a pump station site.




