Thence along the easterly and southerly line of said Parcel No. 1200WL and the right-of-way line of Interstate Route 270 as shown on said right-of-way plan FRA-270-28.3N the following six (6) courses:

- 1) North 16°33'38" East, 255.98 feet to a 3/4" iron pin found with a cap reading "6872";
- 2) North 35°22'11" East, 244.41 feet to a 3/4" iron pin found with a cap reading "6872";
- 3) North 59°19'54" East, 328.02 feet to a 3/4" iron pin found with a cap reading "6872";
- 4) North 85°11'53" East, 223.61 feet to a 3/4" iron pin found with a cap reading "6872";
- 5) South 76°46'04" East, 202.24 feet to a 3/4" iron pin found with a cap reading "6872";
- 6) South 73°21'46" East, 265.50 feet to an iron pin set at the northwesterly corner of Reserve "A" as shown in Crescent at Central Park Section 1 in Plat Book 125, Page 25;

Thence along the westerly line of said Reserve "A" the following two (2) courses:

- 1) South 05°51'43" East, 943.66 feet to an iron pin set;
- 2) South 18°21'54" West, 371.55 feet to an iron pin set on the northerly right-of-way line of said Tech Center Drive and the northerly line of said Parcel 3-WD;

Thence along the northerly right-of-way line of said Tech Center Drive and the northerly line of said Parcel 3-WD, along a curve to the left having a radius of 1560.00 feet, an arc length of 763.65 feet, a deflection angle of 28°02′51″, and a chord bearing and distance of South 75°30′59″ West, 756.05 feet to **THE TRUE POINT OF BEGINNING**, containing 40.807 acres (1,777,538 S.F.), more or less.
