Dear Mr. Wetherholt:

Enclosed is our proposal to initiate the preliminary design for the referenced project.

PROPOSED WORK

This intersection is to be improved to handle the 2022 traffic as determined by the current traffic study. This study is to determine the number of lanes and their movement on each approach, and the storage length required for the signalized intersection.

The existing intersection angle is $42 \pm$ degree. The desirable intersection angle is 70 degrees to 90 degrees with 60 degrees acceptable for signalized intersections. It is possible to correct the 42 degree intersection to 70 degrees.

This cost proposal covers the initial survey and studies to initiate the project. During this study the number of lanes, storage lengths, alignment and pavement transitions will be determined. A preliminary cost estimate will be prepared and coordination with utilities initiated. The bridges on Morse Road and USR 62 over Rocky Fork Creek will be widened and will require approval coordination with FEMA and the Corps of Engineers. Necessary coordination with other local public agencies, City of Columbus, Franklin County, ODOT and New Albany, will continue.

COMPENSATION

Moody/Nolan will invoice Gahanna for the actual payroll cost for work preformed plus overhead and profit. Subconsultant costs will be invoiced to the city at our cost. The estimated maximum cost for the preliminary study is \$42,405.00. See the attached labor and cost summaries.

- 1. Detailed Construction or Right of Way Plans
- 2. Environmental Studies or Documentation
- 3. Risk Analysis or Flood Plain Study
- 4. Right of Way Appraisal or Acquisition
- 5. Bid Documents
- 6. Construction Inspection or Testing
