MOBILIZATION, REMOVE OLD SEWER BETWEEN REPAIRS AND INSTALL NEW 8" PVC, CONNECT EXISTING LATERALS, REPLACE ASPHALT, REPLACE SIDEWALK, GRADE AND SEED.

EXCLUSIONS AND UNKNOWN ITEMS:

- NO RELOCATION OF EXISTING UTILITIES SUCH AS PULL BOXES OR CABINETS FOR FIBER OPTIC, PHONE, TRAFFIC SIGNAL OR ELECTRIC
- NO RELOCATION OF WATER LINES OR STORM LINES THAT MAY BE IN CONFLICT EITHER PARALELL OR CROSSING NEW SEWER
- NO BY-PASS PUMPING OF EXISTING SEWER INCLUDED, WE PLAN TO REMOVE AND REPLACE AS WE GO
- ALIGNMENT WILL NEED TO BE PERFORMED BY GAHANNA
