ARTICLE III SECTION 3.06 ACTING MAYOR

the event of death, resignation, recall, or removal of the Mayor, the President of Council or any member of Council designated by majority vote of Council, in that order, shall become the Mayor, to serve until the certification of results by the Board of Elections of the next election or for the balance of the unexpired term, whichever occurs first, and his office as Councilman shall become thereby vacant; provided that if the Mayoral vacancy occurs within ninety (90) days of the next election and the Mayoral position is not already on the ballot in that election, the new Mayor shall serve until certification by the Board of Elections of the results of the next following election or for the balance of the unexpired term, whichever occurs first. The salary of the Mayor for the balance of the term shall be that established by the nance for the term as provided
