Dear Mr. Weatherholt:

GGC Engineers, Inc is pleased to submit for your consideration this proposal for bidding, construction administration and resident engineering services for the new 6" waterline extending approximately 1,470 feet east on Price Rd. from the intersection of James Road and Price Road.

We propose to provide professional engineering services to the City of Gahanna, OH, (herein referred to as the "Client"), in accordance with the terms and conditions set forth herein:

- Bidding Services to consist of developing technical specifications for inclusion into City of Gahanna supplied contract bid contracts, conducting a pre-bid meeting with prospective bidders and holding a pre-construction meeting with the successful bidder. (Bid advertising, distribution of construction documents, construction plans and specifications to prospective bidders will be performed by the City of Gahanna).
- 2. Construction administration services including investigation of the apparent low bidder's qualifications and references, and processing of all contractor payment requests.
- 3. Resident construction inspection services consisting of a qualified inspector overseeing installation progress and conformance with the plans and specifications as well as verification of quantities noted in contractor pay requests.

4. After completion of the project, we will provide the Client with a copy of the entire survey and design on a CD-ROM formatted for AutoCAD R14.0. The CD ROM will be supplemented by 24" X 36" mylar plan and detail sheets.

We anticipate the public bidding period to be the normal 15 days, with the actual waterline construction to take approximately 30 calendar days.

Fee and Billing

We will accomplish this work as outlined above, as requested by the Client for a fee as follows:

•	Bidding and plan distribution services	-	\$ 300.00
•	Construction administration services	-	\$ 700.00
