## ACTION ITEM \#1: REQUEST FOR SUPPLEMENTAL APPROPRIATIONS

Council approved, then amended, agreements related to the Tech Center Extension with Science One on December 5, 2022. Along with the agreements were changes to appropriations which included transfers out of the Central Park TIF in the amount of $\$ 250,000$ and out of the Water Capital Fund in the amount of $\$ 85,100$ for the City's share of the project. These funds were to be transferred to the Tech Center Fund 4320. Unfortunately, these appropriations lapsed at year end, as the transfers were not made before the close of the year. New procedures have been implemented to analyze all interfund activity before the close of the year occurs. While this was performed for originally-appropriated activity, the supplemental appropriations were not incorporated. As a result, these transfers must now be re-appropriated in accordance with the agreements adopted December 5, 2022, in order to reimburse the developer for the City's share of the project. A supplemental appropriation therefore is respectfully requested for the Central Park TIF Fund and Water Capital Fund as outlined below
