1. Champion Energy Supply Agreement

ORD-0072-2016

TO AUTHORIZE THE MAYOR TO ENTER INTO AGREEMENT WITH CHAMPION ENERGY SERVICES, LLC FOR ENERGY SUPPLY 2018 THROUGH 2020; AND TO DECLARE AN EMERGENCY.

Franey said as we enter into energy contracts, we usually need to strike immediately; but need to wait for legislation; thought we solved in 2014 with Traditions; they are our energy consultant; then we can strike immediately when something comes up; signed with Champion for 2015-2017; got a lower rate; Tradition called us and suggested to put out another RFP to get a lower rate beyond 2017; did that and got a rate at 14% less than we are paying now with Champion; would be beyond 2017 into 2020; there are two things we pay, the rate for the energy and then AEP for distribution; probably talking about a 10% reduction in the future years; wanted to enter into that agreement;

Champion got burned by a government in the past and in future years, the panel said they did not approve it and will not honor that; they will no longer allow entering into agreement without legislation; Tradition talked to Champion a lot and they agreed to hold this price while we got Council legislation; asking for legislation to authorize this; Larick asked annual spend; Franey said do not have that number, in 100s of thousands; Schnetzer said there are a lot of forwards in this process taking place behind the scenes; McGregor asked if they need a waiver and emergency; Franey said would be ideal but did not give them a timeline; understands they will hold the price for our process; Larick said consent with emergency.

RECOMMENDATION: Consent Agenda with Emergency.
