Situated in the County of Franklin, State of Ohio, City of Gahanna, and being located in Quarter Township 2, Township 1, Range 16, United States Military Lands and the 0.25 acre tract conveyed to Paul Sarina and Betty K. Sarina by Instrument of Record in Official Record 1358, Page E20, all references being to the Recorder's Office, Franklin County, Ohio, and bounded and described as follows:

Grantor, his heirs and assigns, hereby release the City of Gahanna from any further claims for compensation or claims for damages resulting from this grant or the construction of said project, except that contractors for the City of Gahanna shall not be released from liability for damage caused by their negligence.

The City of Gahanna, as soon as practicable after construction of said utility and all subsequent alterations and repairs thereto, shall cause all affected property of Grantor to be restored to its original contours and seeded as soon as is reasonably possible. This covenant to run with the land.

The rights granted herein shall not be construed to interfere with or restrict the use of the premises with respect to the construction and maintenance so long as the same are so constructed as not to impair the strength or interfere with the use and maintenance of said utility.
