- 1) Buckeye Power Sales Company assumes no liability or responsibility for any injury or damage arising from the operation and use of the Rental Unit while in the care, custody and control of Renter. Renter shall be fully responsible and liable for the consequences of the use of the Rental Unit and shall hold Buckeye Power Sales Company harmless therefore.
- 2) Renter intends to personally inspect the Rental Unit at the time of delivery; acknowledges receipt of the Rental Unit in good, first-class condition; that said Unit is acceptable for Renter's intended use; and that the Rental Unit shall be returned to Buckeye Power Sales Company when due, in like condition and repair, normal wear and tear expected. For purposes of this Rental Agreement, the following terms shall apply: "day" shall mean (8) hours during a twenty-four hour period; "week" shall mean (3) thru (7) days or (40) hrs in a calendar week; "month" shall mean (28) days or (160) hrs during a calendar month. Renter shall keep the Rental Unit in good condition and repair, providing necessary and customary maintenance.
- 3) Renter shall prohibit anyone, other than Buckeye Power Sales Company personnel, from altering, repairing, or adjusting the equipment in any manner.
- 4) At the request of the renter, Buckeye Power sales Company will service the equipment at renter's expense
- 5) Renter shall obtain and keep in full force and effect an insurance policy that provides full coverage against liability collision and comprehensive loss as the result of the use and operation of the Rental Unit by Renter, its agents and employees. In the event the Rental Unit is determined by Buckeye Power Sales Company to be lost, stolen, damaged or destroyed beyond repair, Renter shall pay Buckeye Power Sales Company in cash, for the Rental Unit, the full stipulated loss value as set forth on the face of this rental Agreement. - 6) Rental Rates for rental time units, as reflected herein, are based upon hours of usage of the equipment as follows:
 - a. For standby to one-shift usage (to a maximum of eight (8) hours per day, or forty (40) hours per week, or 160 hours per month), the base rate applies.
 - b. For two-shift usage (to a maximum of sixteen (16) hours per day, or eighty (80) hours per week, or 352 hours per month), the base rate multiplied by 150% applies.
 - c. For unlimited usage, the base rate multiplied by 200% applies
- 7) If Renter fails to pay rent or other amounts due and payable hereunder, within ten (10) days after the due date' or if Renter is in breach of any term and condition of this Rental Agreement, which breach remains uncured for a period of ten (10) days after notice thereof from Buckeye Power Sales Company, the Rental Agreement shall be deemed in default. Upon default, without court order or other process of law, and without being guilty of trespass or conversion, Renter hereby waives any and all damages occasioned by such repossession. Notwithstanding any such repossession, Renter shall remain liable for the full possession of the Rental Unit.
