**Memorandum of Agreement**

This Memorandum of Agreement ("Agreement") is made as of (5/13, 2016), by and between the City of Gahanna, 200 S. Hamilton Road, Gahanna Ohio 43230, and the Mid-Ohio Regional Planning Commission, 111 Liberty Street Suite 100, Columbus Ohio 43215; hereinafter referred to as (MORPC).

WHEREAS, the parties seek to enter into a collaborative partnership for the education and training of students; and

WHEREAS MORPC has agreed to provide coordinating support for three (3) student(s) and

WHEREAS, to ensure an internship that is satisfactory; the parties agree as follows:

1. MORPC will provide a Summer Internship Program Coordinator; duties will include an orientation class, overseeing a mentor program, correspondence, and periodic interaction with the host City of Gahanna to check on satisfaction with their internship experience to allow for mid-course adjustments on the part of both the Intern and the City of Gahanna.
2. The interns will be employed by the City of Gahanna and will be paid a minimum hourly rate of \$10 per hour (undergraduate) and \$13 per hour (graduate) for the summer period less any required taxes and/or benefits beginning May 16, 2016 and ending August 19, 2016.

3. ~~The Intern will be subject to all relevant City of Gahanna personnel policies and procedures while interning at City of Gahanna. The City of Gahanna may release the Intern for cause at any time after consultation with MORPC.~~
4. The CITY OF GAHANNA will be financially responsible for paying the hourly wage directly to the intern (less any required taxes and/or benefits), the intern program fee of \$600 per intern payable to MORPC and any required fees for CITY OF GAHANNA to conduct a pre-employment drug test and/or background check.

5. City of Gahanna will be required to provide each Intern an evaluation of their job performance at the end of the summer appointment.
6. The commitments in this agreement will continue until August 19, 2016. Either Party may terminate this Agreement by giving written notice to the other Party thirty (30) days in advance of the termination date. If the organization terminates the agreement before the end of the stated period, the organization must make payment in full up for any completed hours of work directly to the intern. The Internship program fee is non refundable.

If a breach occurs and the breaching Party fails to cure it within a reasonable period of time, this Agreement will terminate at the close of business on the 30<sup>th</sup> day following receipt of written notice.

7. Each Party to this Agreement shall be responsible for any liability, claim, loss, damage or expenses, including without limitation, reasonable attorney fees, arising from its negligent acts or omissions in connection with its performance of this Agreement, or its failure to comply with the terms of this Agreement, as determined by a court of competent jurisdiction.
8. Neither Party shall use the name of the other Party in any advertisement or in public statement of any kind, or in any medium, without first obtaining the written permission of the Party whose name is used.
9. This Agreement is the entire understanding of the Parties on its subject matter and supersedes all prior oral and written agreements with respect thereto. It may be amended only by a writing signed by both Parties specifically stating intent to amend this Agreement.




