Taylor Road Water Main Replacement Project
Request for Amendment No. 1

On September 11, 2024, the City accepted Fishbeck's proposal for design, bidding, and construction administration services for the installation of new water main along Taylor Road between Morrison Road and Helmbright Drive. At 90% Design, the City directed Fishbeck add sidewalk replacement design to the scope of work; however, no amendment was given for the sidewalk change in scope at that time. Fishbeck agreed to monitor the budget and seek an amendment for the sidewalk design if necessary. The cost to complete the sidewalk design was \$25,454. At this time, Fishbeck has \$1,923 remaining in our budget to complete the construction administration tasks of the work.

The City and Fishbeck determined the following services are required to complete the sidewalk replacement portion of the project through post-construction:

- Fishbeck Engineering Services during Construction:
 - RFI, RFP, and Change Order management
 - Submittal reviews
 - Assistance in determining if work performed by the contractor does not meet the requirements of the project's contract documents
 - Management of construction inspection work performed by subconsultant Stantec Consulting Services Inc. (Stantec)
- Stantec Construction Inspection Services:
 - Construction inspection (see attached Stantec proposal)

Professional Services Fees

Fishbeck proposes to provide the outlined services on an hourly rate plus reimbursable expense basis for a not-to-exceed fee of Sixty-Nine Thousand Seven Hundred Twenty-One Dollars and Eighty-Six Cents (\$69,721.80). A breakdown of our professional services fees is provided in Table 1.

Scope of Services

Taylor Road Waterline Replacement Inspection Proposal

- The proposed fee is based on the provided construction schedule and a planned construction inspection duration of 5 months in the 2026 construction season. Inspection time is expected to be full-time. However, part-time work will be utilized when possible to match the contractor's needs.
- Field inspection shall observe and report on contract conformance to the construction documents provided at the time of proposal.
- Inspection responsibilities will include documenting the contractor's work in daily reports, plan and specification compliance, managing material acceptance, and compaction testing within the right of way.
- Provide redline drawings detailing sanitary sewer as-built information. Survey information will be collected from the contractor.
- Provide redline drawings detailing water service as-built information from the existing main to the meter room. Survey information will be collected from the contractor.
- Observe and document deflection and leakage testing of the sewer as detailed in the CMSC 901.
- Document and manage the project punch list.
- Provide material testing services as authorized by the City of Gahanna
- Conduct SWPPP inspection as required by the general permit or applicable requirements and in coordination with Franklin County Soil and Water.
- Completed daily reports, redline mark-ups, field drawings, and all other pertinent inspection documents will be turned over to the City of Gahanna at project completion.
- Engineering, survey, and construction management services, such as responding to RFI's, record plans, plan errors, and engineering recommendations, are not included in this estimate. Services not included may be provided following written directions from the City of Gahanna.
 - The RPR's duties will include:

- 1) Reviewing the Contractor's Preliminary Schedules.
- 2) Attending preconstruction conference and monthly progress meetings and meeting with Contractor on-site.
- 3) Serving as the City's and Fishbeck's liaison with Contractor.
- 4) Assisting in obtaining details or information from the City when required for proper execution of the work.
- 5) Receiving samples furnished at the site by the Contractor.
- 6) Observing Work in progress and assisting in determining if it conforms with the Contract Documents.
- 7) Reporting any Work that he/she believes does not conform generally to the Contract Documents.
- 8) Observing and reporting on major inspections, tests, and system start-ups.

- 9) Accompanying visiting inspectors having jurisdiction over the Project and reporting on these inspections.
- 10) Informing the project manager that clarification/interpretation of the Contract Documents may be needed.
- 11) Preparing a Daily Construction Report for each day on which construction oversight is provided.
- 12) Reporting accidents, hazardous environmental conditions, emergencies, acts of God, and property damaged.
- 13) Reaching agreement with Contractor's superintendent regarding line items and quantities to be billed.
- 14) Participating in the Substantial Completion Inspection and in the Final Inspection.

b. The RPR duties shall not include:

- 1) Approving any deviation from the Contract Documents, or substitution of materials or equipment.
- 2) Exceeding the limitations of the Engineer's authority, as set forth in the Contract Documents.
- 3) Undertaking any of the responsibilities of the Contractor, subcontractors, and Contractor's superintendent.
- 4) Advising on, directing, or assuming control of means and methods of construction.
- 5) Advising on, directing, or assuming control of safety precautions and programs.
- 6) Accepting shop drawings or samples from anyone other than the Contractor.
- 7) Authorizing the City to occupy the Project in whole or in part.
- 8) Participating in specialized field or laboratory tests or inspections.
