**1. Mayor**

Mayor Jadwin said they have been fielding calls for missed pickup for trash and recycling; the delays are not unique to Gahanna but are regional; caused by multiple factors such as an increase in trash, labor shortage; Rumpke is hiring and offering sign on bonus; asks for patience during this process; we are in daily contact with Rumpke; utility billing has a list of residences that have been missed.

Looking for people for summer jobs for Parks & Recreation; listed under "find a job" on city website; many opportunities; need to be able to staff pools and camps.

Welcomed Mr. Camacho as the new project inspector. Thanked Bowers and Angelou for Air Quality Awareness Resolution; included a proclamation for that as well as Herb Week and National Small Business Week (see attached). Next year will be the 50th anniversary of Herb Capital designation. This week is also Public Service Week. Thanked Visit Gahanna and Herb Center staff for the Herb Day this past weekend. Congratulated Jon Cooper and Cameron Cheesemen, Gahanna Lincoln High School graduates for being drafted into the NFL.
