

0.840 ACRES

Situated in the State of Ohio, County of Franklin, City of Gahanna, located in Quarter Township 2, Township 1, Range 16, United States Military Lands, being part of the 3.388 acre tract conveyed to Leader Development, LLC by deed of record in Instrument Number 200603150049064 (all references are to the records of the Recorder's Office, Franklin County, Ohio) and being more particularly described as follows:

Beginning, for reference, at a railroad spike found at the centerline intersection of Hamilton Road and Johnstown Road (U.S. Route 62), being the northwesterly corner of that 0.223 acre tract conveyed to the City of Gahanna by deed of record in Instrument Number 199906220158186;

thence North $34^{\circ} 55' 52''$ East, a distance of 98.88 feet, with the centerline of said Johnstown Road, to a railroad spike found at the southwesterly corner of said 3.388 acre tract;

thence South $85^{\circ} 19' 07''$ East, a distance of 46.23 feet, across said Johnstown Road (U.S. Route 62), and the northerly line of said 0.223 acre tract, to a $\frac{3}{4}$ inch iron pip capped "C Turner 6702" found, the TRUE POINT OF BEGINNING;

thence South $85^{\circ} 19'07''$ East, a distance of 154.03 feet, across said 3.388 acre tract, to a $\frac{5}{8}$ inch rebar found at the northeasterly corner of the 1.956 acre tract conveyed to James R. and Debra Boyd by deed of record in Official Record 3049 H11;

thence South $04^{\circ} 38' 49''$ West, distance of 199.70 feet, with a westerly line of said 1.956 acre tract, to $\frac{3}{4}$ -inch iron pipe found;

thence North $85^{\circ} 28' 07''$ West, a distance of 187.90 feet, with a northerly line of said 1.956 acre tract and with a portion of the northerly line of that 1.217 acre tract conveyed to Herbert P. and Joan Wilke by deed of record in Official Record 3050 B09, to an iron pin set at the southeasterly corner of that 0.039 acre tract conveyed to City of Gahanna by deed of record in Instrument Number 200401150011140;

thence North $04^{\circ} 32' 12''$ East, a distance of 141.37 feet, with the easterly line of said 0.039 acre tract, to an iron pin set in the easterly line of said 0.223 acre tract;

thence North $34^{\circ} 47' 12''$ East, a distance of 68.00 feet, with an easterly line of said 0.223 acre tract, to a $\frac{3}{4}$ -inch iron pipe capped "C Turner 6702" found at the northeasterly corner of said 0.233 acre tract, to the TRUE POINT OF BEGINNING, containing 0.840 acres of land, more or less.
